Report and enquire about questionable connection at 57, Dingsai Para Rd.


I, Chirantan Mukherjee, S/O Late Wg. Cdr. A.K. Mukherjee, am a resident of 56, Dingsai Para Road, under your service area.

This is regarding, and for your information, the order of U/s 144(2) CrPc (Misc Petition No. 295 of 2022) in the Office of 2nd Court of Ld. Executive Magistrate, Howrah – being in effect from 7th March 2022, and currently further extended till 15th June 2023 on obvious grounds. And this has reference to my earlier letter to yourself on 26/08/2022, pertaining to our 'objection to an attempted unlawful connection on 13th August 2022 at 57, Dingsai Para Road, Bally. Please find the same publicly available for your kind perusal at: https://www.storyof57.com/cesc-attempt

In my earlier letter, as above, I had explicitly explained:

- 1. A 'defunct' post was planted on our premises, without our prior permission and on the assurance that it will be later removed, on 16th May 2019. This was done to aid the deconstruction-construction process at 57, Dingsai Para Rd on their behest, with no prior interaction with us;
- 2. That the above-mentioned magisterial order was in effect, and any such change shall not only cause a change in status-quo disfavouring us but also pave way for change in 'meter box' locations constructed controversially, and in violation of the above-mentioned magisterial order;
- 3. That establishing one or more connections at the same place, is controversial and objectionable, and therefore has dire consequences. As such, no such requests for new or change of connection should be entertained, especially in view of the above-mentioned magisterial order. This is also because any solution/connection should consider removal of the 'defunct' post unlawfully planted on our premises.

Connected to change status on 29th March 2023

Notwithstanding such communication, as in the Before-and-After pictures included above, please note that your office has proceeded to establish such connection on 29^{th} March 2023 – without any consultation with us.

This attempts to drastically change the status-quo, changing the 'defunct' post into an active one, and hinders our pursuit of justice – in the context of the overall wrongdoings against us and the attempted encroachment into our property.

And this is despite our objections, in the previous such attempt on 13th August 2022 – making us helplessly wonder: what changed, for which your esteemed office to pursue such action in violation of the afore-mentioned magisterial order?

- Despite the magisterial order being still in effect, as before;
- Despite the 'defunct' post being unlawfully planted on our property, as before;
- And, despite my written communication informing your office of the reasons for our objection and complications of any such change.

It is disappointing to state the least, to watch the might of your esteemed office being misused to muscle into our property, and violate the afore-mentioned magisterial order.

As presented in the footages above, more than 15-20 people were engaged to muscle into our property for such activities – that we had objected before and provided explanations to your esteemed office in written.

And the footages above also include people from the neighborhood peeking to watch your office making a complete mockery of the afore-mentioned magisterial order, and using our property to violate the very magisterial order that is meant to protect it.



Furthermore, as I had pointed in my afore-mentioned previous letter, such a change has enabled installation of a new set of connections – paving way for new possessions, in violation of the magisterial order – set-up in the controversial construction that was made in violation of the said order – as mentioned in my previous letter, and as illustrated in the picture included herewith.

Under such circumstances, if your actions cannot be retracted and undone unconditionally at the earliest, please provide us with the necessary procedures (including costs): in order to segregate the lines, and to have the 'unlawfully planted' post removed.
